

#### **FOOTNOTES 2019**

- a. Reflects regular Sunday offerings, Direct Electronic Fund Transfer's, Easter, Christmas & Initial Offerings. In 2019 this account increased 0.8% over 2018.
- b. Funds supplied by regular parishioner and memorial donations towards the church and rectory repairs. In 2019 this account decreased 12.5 over 2018.
- c. Funds supplied by regular monthly donation envelopes which are now being invested with the Diocese at a higher rate of interest. This account decreased 31.7% over 2018.
- d. Bequests were made to the Building Fund in 2019. The funds were used to help fund repair work of a larger magnitude on the Basilica.
- e. Interest earned on last Scotiabank GIC redeemed in November and invested with Diocese and interest earned on Operating & Building Fund balances.
- f. Funds raised for the "Restoration of the Church on the Hill" campaign for 2019. Contributions decreased by 28.6% over 2018.
- g. Grants received from Other Registered Charities: Canada Helps and the Knights of Columbus.
- h. Interest Earned with the Diocese on Heritage Fund investment.
- i. Parishioner support for the 2019 Diocesan regular and relief collections.
- j. Church expenses increased by 16.5% over 2019 while rectory expenses decreased by 49% over 2019 which reflects the rectory being vacant during renovations throughout 2019.
- k. Expenses for the organ, choir, religious articles, books & pamphlets, flowers. This account increased by 72% owing to a major organ repair.
- I. Office and Administration expenses increased by 53.4% with the installation of the new computer system.
- m. Laity salaries have increased by 2.9%.
- n. Cathedraticum (13% for 2019) is an assessment levied by the Diocese on total offerings. We still have temporary exemption for the Heritage Fund and Building Fund including the Capital Campaign. No payments were made in 2019. Funds were used to help pay for major repair projects at the Basilica.
- Major repair work at Basilica front stairs and ambulatory exterior, investigations for future repair work & engineering costs.
- p. Heritage Funds on Deposit at the Diocese
- q. Balance of the Loan with the Diocese as of December 31, 2019.

Throughout 2019 work continued on the new Rectory and office buildings. As walls were opened our contractors often discovered surprises hiding behind them, which sometimes entailed a change to the expected work, as some areas needed to be made more structurally sound, and other areas became a bit smaller than originally planned. All in all though, the work proceeded well throughout the year and we were able to take occupancy in June 2020. The usual maintenance continued on the Basilica, and the grounds. Thanks to our caretaker, and to all those who work so hard to keep "Catholic Hill" in good shape. Two of the property highlights of 2019 were the 100<sup>th</sup> Birthday of our organ, which was installed shortly after the end of the First World War, and a beautiful new statue of Jesus and the Children in the Garden of Grace. If you haven't already seen it, do take the time to take a look.
